Camp Goodtimes: We again held two camp sessions during the summer - each a week long, serving a combined population of approximately 220 pediatric cancer patients and their siblings coming from the northwest region (including children from Alaska).

Pilot Programs: In FY 2018, we introduced a few one-day programs that allowed our families to gather on a more regular basis - Gaming with Goodtimes happened on two occasions serving 15-20 families each time. We cohosted a one-day parent round table and child carnival with Camp Side By Side serving an additional 15 families. We also served an additional 10 families by providing a Sibling Ski Camp.
