Camp Goodtimes: We held two camp sessions during the summer; each was one week long, and combined, we served approximately 220 pediatric cancer patients & their siblings from the northwest region (including children from Alaska).

4b (Code:) (Expenses \$ **74,184.** including grants of \$) (Revenue \$)

Pilot: Our pilot program provides more opportunities for the families and children we serve to connect and participate in fun activities throughout the calendar year, not just in the summer. A great example of this was our You & Me Retreat which was held in late February and was attended by 80 parents and children representing 40 families. This program was designed to provide a unique experience for one parent or guardian and one child from a family who has experienced pediatric cancer, and to rebuild their connection.

Camp Kayak: We held a week-long kayak camp for young adult pediatric cancer survivors. We had 9 campers attend this camp.
